Resource of the Community Fund for Women's Support more than 143 billion soums to 5,600 women at the expense of funds loans were allocated.

Housing for women living in difficult living conditions Support for women and the family funds of the public fund were directed.

Contribution of women in social and economic development increased recognition. In particular, young people and women a program of five initiatives covering was developed.
